The privacy and confidentiality of our students and their families is one of Elim's top priorities. Parents/Guardians understand that as a therapeutic school, Elim may have access to information about your child, the family, the child's and family members' mental health history, diagnoses and other information. Further, Parents/Guardians understand that a student's appearance in any Elim marketing material, including in any photo, audio or video publication, inherently implies that the child is a student of Elim, a therapeutic day school.

CONSENT FOR EXTERNAL USE OF PHOTOS & AUDIO/VIDEO RECORDINGS

Parents/Guardians understand that Elim reserves the right to utilize its photos and audio and/or video recordings of its students, which may include the student's name, identity, likeness, for internal purposes, and that such use is **not** considered a disclosure of personally identifiable information. Parents/Guardians also understand and agree that there may be shared use of visuals and schedules by students, that may include the information of other students for learning purposes, and so incidental disclosures may occur among students and their families. This release form shall expire on 7/24/2025; however, the expiration or revocation of this release does not require Elim to remove, rescind or destroy any external school publications and/or marketing materials that have already been produced, published, posted or distributed.
